1. How to contact us:

2. Collection of information and purposes of collection:

We collect the following categories of personal information about you:

- ✧ email address.
- ✧ the type, version, brand, language and operating system of device.
- ✧ the type and operator of network (such as Mac address).
- ✧ behavioral usage of the App.
- ✧ device identifiers (such as IDFA, IDFV for Android, GAID for IOS).

We collect the above information in order to:

- ✧ Provide you Service and support.
- ✧ Perform analytics in order to provide you with personalized Service.
- ✧ Perform analytics to improve the App and business operations.
- ✧ Detect and prevent fraud.
- ✧ Comply with legal obligations such as business reporting, auditing and tax.
- ✧ Comply with applicable laws.

3. Who do we share your personal information with:

We may share your personal information on a need-to-know basis with the following parties:

- ✖ Our team members. Authorized members of our teams who need to access your personal data, strictly to perform their jobs.
- ✖ Regulatory authorities. When appropriate, we may share data with competent courts, mediators, accountants, auditors and lawyers.
- ✖ Additionally, we may share all or part of your personal data with our service providers.

We store your personal data only as long as needed for the purposes described in this Notice. Sometimes, we may keep your data longer to comply with our legal obligations and/or for legal proceedings. Once the legal retention periods have expired, we will permanently delete the data.

6. How we keep your personal information secure:

To prevent loss, unauthorized access, use or disclosure and to ensure the appropriate use of your information, we utilize reasonable and appropriate physical, technical, and administrative procedures to safeguard the information we collect and process.

7. How we protect children's privacy:

The App is made for the general public. We do not knowingly collect data

from children under age of 13 or as defined by local law without the previous consent of their parents or legal guardians or as otherwise permitted by applicable law. If you are a parent or guardian and you believe we have inadvertently collected information from your child or used/shared information from your child through the App without your consent, please contact us and we will remove the data to the extent required by applicable law.
